- 2. Incomplete submittals will be returned to the homeowner and will not be reviewed.
- 3. The homeowner is responsible for obtaining all city and county permits, which must be submitted with the application form.
- 4. Include a copy of any blue prints, samples, sketches, photos, color schemes, site plans, paint swatches, etc. of the proposed changes.
- 5. Applications to the Warner Woodlands Townhomes Homeowners Association are not subject to an application fee.
- 6. You will be notified in writing of the result of your request. Please allow adequate time for review prior to scheduling work.
